Councilmember Jack Evans, Chairperson of the Committee on Finance and Revenue, announces a public hearing on Bill 17-141, the "New E-conomy Transformation Act of 2007"; Bill 17-292, the "Arthur Capper/Carrollsburg Public Improvements Revenue Bonds Approval Amendment Act of 2007"; Bill 17-295, the "Fiscal Year 2008 Tax Revenue Anticipation Notes Act of 2007"; Bill 17-342, the "Tregaron Conservancy Tax Exemption and Relief Amendment Act of 2007"; Bill 17-343, the "Wax Museum Tax Abatement Allocation Modification Amendment Act of 2007"; and Bill 17-344, the "Constitution Square Economic Development Act of 2007". Bill 17-141, the "New E-conomy Transformation Act of 2007", was introduced by Councilmembers David Catania and Jack Evans and would extend certain provisions of D.C. Law 13-256, the "New E-Conomy Transformation Act of 2000" for an additional 5 years as an incentive for high tech companies to locate in the District.

Bill 17-292, the "Arthur Capper/Carrollsburg Public Improvements Revenue Bonds Approval Amendment Act of 2007", was introduced by Chairman Vincent Gray at the request of Mayor Fenty and contains technical clarifications to D.C. Law 16-244, the PILOT Authorization

Increase and Arthur Capper/Carrollsburg Public Improvements Revenue Bonds Approval Act of 2006, recommended by the Mayor with respect to the issuance of these revenue bonds.

Bill 17-295, the "Fiscal Year 2008 Tax Revenue Anticipation Notes Act of 2007", was introduced by Chairman Vincent Gray at the request of Mayor Fenty. It would authorize the District's annual short-term borrowing in advance of anticipated tax revenues for the fiscal year.

Bill 17-342, the "Tregaron Conservancy Tax Exemption and Relief Amendment Act of 2007", was introduced by Councilmember Mary Cheh and would exempt from property taxes the property to be transferred to and owned by the Tregaron Conservancy.

Bill 17-343, the "Wax Museum Tax Abatement Allocation Modification Amendment Act of 2007"; was introduced by Councilmembers Tommy Wells and Jack Evans, and would modify the allocation of previously allocated tax abatements for this project, as approved under D.C. Law 15-329, the Tax Abatement Adjustment for Housing Priority Area Act of 2004.

Bill 17-344, the "Constitution Square Economic Development Act of 2007", was introduced by Councilmembers Tommy Wells and Jack Evans, and would provide a variety of tax incentives to the Constitution Square mixed-use development project, including a new supermarket, to be located in Ward 6.
